Rangsin a College is the prime higher educational institution in the Hamren Sub-Division. Established during the Eighties of the last century (23rd Nov. 1983) it has served well this economically and educationally backward section of the district with its available resources.

Initially the syllabus and other academic activities of Rangsin a College was related with the Gauhati University. During the year 1994, it comes under the purview of Assam University along with the other colleges of Karbi Anglong District and got permission to continue the college activities from the same.

Starting with a handful of students Rangsin a College has achieved an amazing growth to get the affiliation from the university during the session 2003-2004 and concurrence from the Govt. of Assam during the year 2005.

The College got permission to open the Major Course in Economics and History during the session 2008-09 and in the same session university granted temporary affiliation up to T.D.C. Part-III to Rangsin a College.

Rangsin a College has one well established Library with a book strength of over 5000 (Five Thousand) copies including reference books. We have accumulated a good number of books every year to cope with the increasing number and necessity from students end. The Library is devoted to the memory of Dr. P.C. Phangocho, one of the eminent scholar and former Principal of the college posthumously. Now the Library has WIFI Coverage.

FROM THE PRINCIPAL'S DESK

It will produce little value from explaining the responsibility of the Principal in the College. A little irresponsibility from the sub-ordinate office members, staff members as well as from the students may disturb the harmony of the functionaries. So, after enrolling into the institution the students should follow strictly the following instructions:

ADMISSION PROCEDURE

The admission to the Rangina College will be in SAMARTH portal developed for UG/PG admissions.

The proposals and resolution adopted at the meeting held on 07-03-2024 on HYBRID mode with the Principals of all affiliated colleges under Assam University, Silchar under the Chairmanship of Honorable Director, College Development Council, AUS.

For a clear understanding the minutes of the meeting is enclosed herewith:

RESOLUTION OF THE PRINCIPALS OF AFFILIATED COLLEGES FOR IMPLEMENTATION OF UG CUET FOR ADMISSION TO UG COURSES IN AFFILIATED COLLEGES OF ASSAM UNIVERSITY.

Date: 07/03/2024

Mode of Meeting: HYBRID

The meeting was attended by Principals / representatives of Principals of affiliated colleges online. Director CDC Mr. Jayanta Bhattacharjee also attended the meeting online. Registrar of Assam University Dr. Pradosh Kiran Nath, Controller of Examinations of Assam University Dr. Suprabir Dutta Roy and AR Examination Mr. Pinak Pani Nath Purkayastha attended the meeting offline. Senior Professor Manabendra Dutta Choudhury was in chair.

Prof. Manabendra Dutta Choudhury welcomed all the members present in the meeting both online and offline and requested Director CDC Mr. Jayanta Bhattacharjee to place before the house the agenda item of the meeting. Registrar Dr. Pradosh Kiran Nath also narrated the purpose of the meeting and briefed the house about the communication received from Govt. of Assam for implementation of UG CUET. After detailed Discussion following resolution have been adopted unanimously.

Resolution No.1: Members unanimously decided to implement CUET for admission to UG courses of affiliated colleges from the session 2024-25. The colleges will fill up 100% of their intake capacity through CUET. However, the vacant seats if any may be filled up with non CUET candidates.

Resolution No.2: Mapping of course for UG CUET considered by the members is as per Annexure-I.

Resolution No.3: The house unanimously resolved that Assam University should communicate the considered course mapping (Annexure-I) for UG CUET of affiliated colleges to NTA for immediate incorporation in their website so as to enable aspirant candidates of UG courses to appear for UG CUET.

Resolution No.4: It is further resolved that all affiliated colleges shall notify the mandatory requirement of CUET for admission to UG courses in their website/prospectus.

Resolution No.5: It is resolved that from 2024-25 session all admission in affiliated colleges shall be through e-SAMARTH portal.

Resolution No.6: Members opined that in order to accommodate huge number of candidates appearing for UG CUET there is a need for good number of test center in Assam University jurisdiction area. NTA may explore online UG CUET exam too.

Resolution No.7: The matter related to admission in excess to actual intake capacity was discussed and Director CDC clarified that e-SAMARTH admission portal per college intake capacity shall have to be mentioned. As such no college will be allowed to admit candidates in excess to actual intake capacity. Colleges interested to increase the intake may approach CDC office for processing and approval.

The Meeting ended with vote of thanks to and from the chair.

Present Day Contrast:

With the change of time, the dimension, aims and activities of Rangsin College has changed a lot. It is the demand of time that we need to extend its physical and academic facilities of this institution as the enrolled students number increases at a faster rate.

The introduction of NEP-2020 also develops some critical problems and issues to the institutions of our status. Shortage of infrastructural facilities as well as man power (specially the Teaching Staff) stands as hindrance to implement the new policy properly.

Being a single stream institution at present we are not in a position to introduce the interdisciplinary approach which is a main feature of the New Education Policy.

Further, new education policy has extended the degree level to four year term, where the last year (Semester vii & viii) will mainly concerned with academic research and practical activities. At present this institution has very poorly developed academic facilities and non availability of expert and trained up faculty members to enable the students to carry out the extended research activities.

Thus, future Government policy will only able to provide pathways for better service to the students enrolled in this institution.

Right now the college administration or Governing Body not in a position to give assurance about the future step of achievements.

- (iv) For AEC (Ability Enhancement Courses - Language), there shall not be any internal exam. Total Marks for AEC examination shall be 50 with two hours examination duration.
- (v) SEC (Skill Enhancement Course) shall have to be opted from either DSC or DSM. Evaluation method for SEC shall be 50 (End Semester Theory) + 30 (End Semester Practical/Project/Field Work)+30 (internal test of which 20 for test and 10 for attendance).
- (vi) For EVS (VAC-151) evaluation method shall be 70 (End Semester exam)+30 Internal/ Assignment. Marks for Internal Test shall again be divided to 20 for written test and 10 for attendance.
- (vii) Evaluation method for VAC-101(with practical) shall be same as that of SEC (with practical) and that of VAC-101 (without practical) shall be same as VAC-151.
- (viii) EVS in VAC-151 should be of 100 level and EVS included in Natural Science Basket as IDC should be of 200 level.
- (ix) For VAC- 151(EVS) shall not have any Practical component.
- (x) For opting DSC and DSM combination,clustering of subjects shall be as per ANNEXURE-III. DSC from one cluster and DSM from other cluster is not allowed. DSC, DSM and IDC cannot be the same subject.

INTERNAL ASSESSMENT & EXAMINATION

1. Examination Schedule:
Odd Semester Examination: 7th Nov. to 30th November.
Result to be published : within 31st January.
Even Semester Examination: 7th April to 30th April
Result to be published: within 30th June.
2. Examination Pattern:
Objective type (In one or two words) : 20%
Very short answer type (In one or two sentences) : 20%
Short answer type (Three or five sentences) : 30%
Broad type and critical (marks in between 5-10) : 30%
3. Unit Tests (compulsory) must be held within:
Odd Semester : 1st Test - July/August.
2nd Test - September/October
Even Semester: 3rd Test - January/February
4th Test - February/March

Each test of 25 marks, qualifying marks is 10 (40%). If any candidate fails to attend or obtain qualifying marks then only one special test may be arranged before the submission of application forms and fees for the examination.

4. Eligibility criteria for admission in examination:
 - i) One should have 75% of attendance both in theory and practical papers. 65% attendance may be considered only on special ground as justified and certified by the principal.
 - ii) One should have to qualify in the unit test securing at least 40% of marks.
 - iii) Full marks and Pass marks for CCA (Unit Test + Attendance)

Courses with only Theory Paper:

Full marks (Unit Test: 20 + Attendance : 10) = 30 (Thirty)

Pass marks = 12 (Twelve)

SEC Courses with both theory and practical papers for Arts stream.

50 marks (Theory + 30 marks (End Sem Practical/Project/Fields work) + 30 marks.

(Unit Test : 14+ Attendance: 6)

Full Marks = Unit Test : 14+Attendance : 6
= 20 (twenty)

Pass Marks = (eight) Unit Test.
